DESCRIPTION OF BUILDING PRODUCT

JSC supplies a variety of solid hardwood flooring timber species. They are created from Australian natives, North American and Pacific Island hardwoods, and are supplied as,

- T & G flooring,
- · Overlay flooring, and
- Parquet flooring.

The hardwood species supplied have at least the same modulus of rupture and elasticity as Radiata pine and may therefore be used as a direct substitute for structural flooring where the dimensions are the same or greater as that provided for in sections 7 & 14 Flooring NZS 3604:2011.

Species offered are as follows,

- Spotted Gum (Corymbia maculata). Durability class 1.
- Blackbutt (Eucalyptus pilularis). Durability class 1.
- Kwila (Intsia bijuga). Durability class 1.
- Tasmanian Oak (Eucalyptus regnans/obliqua/delegatensis). Durability class 3.
- American White Oak (Quercus Alba). Durability class 3.

Where slip-resistance is required, JSC supply slip-free strips.

JSC is the trading name of J Scott & Company.
